- All electrical cords, fittings, switching etc. are to be in accordance with the appropriate Australian Standard
- Any rubbish generated by the activity must be removed before leaving the site.
- There are to be no glass receptacles used in the park.
- The use of pegs to secure a tent or structure is strictly prohibited.
- No vehicles are permitted on parks at any time
- Items that may be used as a weapon should not be left unattended.
- The approval holder must display the approval in a prominent position at the stall so it is easily visible.
- Trading hours are 2pm-6pm Friday, 7am-6pm Saturday, 7am-3pm Sunday. Council will not accept any liability for theft or damage to any property.
