This checklist is to be used for all building applications submitted to Council for assessment. All plans are to be submitted in A3 size only, or via email to mail@cook.qld.gov.au in pdf format or on a USB.

*Cooktown has a minimum wind classification of C2. Before purchasing kit buildings, including carports and sheds, check the engineered plans and Form 15 to ensure the building has the correct wind classification to be approved by Council.

	Energy Efficiency Compliance Certificate.	
	Qld Building Construction Commission (QBCC) Confirmation of Insurance Certificate. Builder to obtain for works over \$3,300 (owner builders are exempt).	
	Owner Builder Permit (<i>if required</i>). An Owner Builder Permit is required where the estimated value of building work (<i>including labour and materials</i>) is \$11,000 or more when not using a licenced builder	
	QLeave Levy (<i>Portable Long Service Leave Scheme</i>) – for construction over \$150,000. This can be submitted online. Owner builders must submit the form, no fee is required to be paid.	
	Copy of proof of ownership if the land is not registered under the current owner's land.

	Energy efficiency compliance certificate for additions to a dwelling (Class 1a).	
	Sewer plan (if applicable).	
	QBCC Confirmation of Insurance Certificate. Builder to obtain for works over \$3,300 (owner builders are exempt).
