5. I undertake to declare any restricted dogs in the "Breed" field overleaf. I understand that a restricted dog is any dog of the following breeds, including cross breeds of these breeds. These breeds are the Dogo Argentino, Fila Brasileiro, Japanese Tosa and American Pit Bull Terrier. Further, I am aware that it is an offence to breed or supply the above breeds and that a permit is required for their keeping.
6. I fully understand that it is an offence to fail to declare whether any of the animals listed overleaf are regulated dogs. (A regulated dog includes a declared dangerous dog, a declared menacing dog or a restricted dog)
