All visitors are invited to join us in celebrating this occasion. We aim to provide an art space that allows you to recognise and appreciate the work of talented local artists. For those interested in art this is an opportunity to associate with artists. The art works on show by professional and emerging artists are for sale in the gallery.

CONDITIONS OF ENTRY

- An entry fee of \$7.00 for each work entered is to be returned with the completed entry form to the Secretary by Tuesday 6th May 2008. Cheques are to be made payable to 'Cooktown School of Art Society Inc.'
NO LATE ENTRIES WILL BE ACCEPTED. LIMIT OF TWO ENTRIES PER SECTION.
- Each entry is to be clearly marked on the back lower right hand corner with the artist's full name, address, title of work, section number and sale price. Please remember that all non-acquisitive entries are "for sale". "Not for sale" entries will not be accepted. Maximum sizes are defined for each section – see list of art award categories.
- All entries must be suitably prepared ready for hanging with D hooks preferred. All unframed works on gallery wrapped canvas (I.E., no visible staples) and the to sides are to be painted.
- All works sold, except those chosen for acquisitive awards will be subject to a commission of 20%
- All entries must be at the Gallery, Charlotte Street, Cooktown, for hanging before noon Monday 26th May 2008. Please remember that we only have a limited amount of time and space so we can't accept any entries after noon.
- All entries for Section 12 'Hand Made 3D Art Form must be in by noon Thursday 29th May 2008.
- Entries, which cannot be delivered personally must have adequate provisions made for their packaging and return at owner's expense.
- The Judge's decision will be final and binding and no discussion or correspondence will be entered into. The Judges have the right to refuse to award a prize in any section if no entry is considered worthy.
- No entry will be removed from the exhibition before noon Tuesday 10th June 2008 except by negotiation.
- The Exhibition Committee will carry out hanging. The Committee has the right to reject any unsuitable works. No discussion or correspondence will be entered into.
- The Society shall not be responsible for loss or damage to any item submitted for exhibition, either while being exhibited, during transit to and from the exhibition, or whilst the artwork is in the possession of the Society. This is irrespective of whether the Society or its servants are negligent or not. Insurance of works is the responsibility of the exhibitor.
- The Exhibition will be officially opened at a preview evening on Saturday 31st May 2008 at 7.30pm, when awards will be announced. The Exhibition will be open to the public from Sunday 1st June 2008 at 9.00am.
