

# COOK SHIRE AERODROME ADVERTISING AND SIGNAGE POLICY

#### INTENT

This Cook Shire Council Aerodrome Advertising and Signage Policy ensures that an integrated and appealing approach is applied to all site and street signage (including advertising) throughout Cook Shire airports.

#### **SCOPE**

The policy applies to all aerodrome signage and advertising.

## BACKGROUND

This Policy aims to ensure that advertising and signage does not detract from the amenity of the airports, is conducive to the growth and development of Cook Shire airports and is of a consistent and high quality standard. Cook Shire Council seeks to encourage the progressive improvement of the airport environment, and is particularly concerned to see improvement in the quality and presentation of its aerodrome facilities.

To achieve the above, this advertising and signage policy aims to ensure an integrated and appealing approach is applied to all airport signage. It applies to all airport tenants, licensees, users and contractors looking to establish a visual presence within the airport precincts. This Cook Shire Council Aerodrome Advertising and Signage Policy requires that a consistent approach be undertaken for all street, tenant and directional signage. The overall objective of the policy is to meet the signage and visibility needs of all tenants while maximising and standardising the design aesthetics of the Councils airport precincts.

# STATEMENT OF INTENT

All airport signage and advertising shall be:

- Compatible with the amenity and visual character of the airport;
- Designed and installed to provide effective communication in suitable locations;
- Of a high quality design and finish; and
- Constructed, installed and maintained to essential safety standards.

Statutory signage that complies to Australian standards is permitted.

Specific procedures for the operational management and application of this policy are contained in the Airport Signage Application Terms & Conditions.

Any additional sign or signs larger than that permitted in the Airport Signage Application will incur an additional annual fee, as specified in Council's Fees & Charges.

#### KEY RESPONSIBILITIES

RESPONSIBLE OFFICER	RESPONSIBILITY
Director Infrastructure	Oversees this policy's implementation and management at Cook Shire Council's aerodromes.
Airport Reporting Officers/Airport Operations Manager	Monitor and report any signage and advertising activity that is not aligned with this policy.
