## **Information Requested**

Cook Shire Council has determined that the following additional information is needed to assess the application:

## GENERAL

- 1. The applicant is requested to update the proposed site plan to clearly identify the following;
  - a. Measurement of the total site area of the proposed self-contained camping area identified on the proposed site plan; and
  - b. The total number of persons proposed to be accommodated within the camping area identified on the proposed site plan.
- 2. Please provide details that illustrate the maximum length of stay for the proposed uses.
- 3. The applicant is requested to provide an *'operation plan'* to address operational aspects such as, bush fire, first aid/emergency management safety guidelines in relation to the dam, safe access and exit from the camp area and waste management.

## **Further details**

The due date for providing the requested information is **three (3) months** from the date of this request, therefore you are required to respond no later than **17 July 2023**.

In accordance with section 13.2 of the Development Assessment Rules, you may respond by giving:

- (a) all of the information requested; or
- (b) part of the information requested; or
- (c) a notice that none of the information will be provided.

As Cook Shire Council's assessment of your application will be based on the information provided, it is recommended that you provide all the information requested. In accordance with section 14.2 of the Development Assessment Rules, if you do not provide a response before the above due date (or a further agreed period), it will be taken as if you have decided not to respond to the information request and the Cook Shire Council will continue the assessment of your application without the information requested.

Please note that Council may request further advice any time before the application is decided if other matters arise as a result of public notification or further assessment of the application.
