## Attachment 2—Advice to the applicant

<b>General advice</b>	
1.	Terms and phrases used in this document are defined in the <i>Planning Act 2016</i> its regulation or the State Development Assessment Provisions (SDAP) v3.0. If a word remains undefined it has its ordinary meaning.
2.	<p><b>Clearing in a Category C area</b></p> <p>Clearing vegetation in a category C or R area on freehold land is not for a relevant purpose under the <i>Vegetation Management Act 1999</i>. Accordingly clearing of vegetation in these areas cannot be applied for under a development approval. Clearing vegetation in these areas must only occur as exempt clearing work or accepted development in accordance with an Accepted Development Vegetation Clearing Code (ADVCC).</p> <p>Clearing vegetation in category C or R areas that is not exempt or in accordance with an ADVCC is prohibited development. Information on exempt clearing work or ADVCCs is available online at <a href="https://www.qld.gov.au/environment/land/management/vegetation/clearing-approvals">https://www.qld.gov.au/environment/land/management/vegetation/clearing-approvals</a></p>

### **The reasons for the SARA decision are:**

The proposed development, with conditions, complies with the relevant provisions of State code 16: Native vegetation clearing, as it:

- Appropriately avoids and minimises clearing, with much of the vegetation on site retained to avoid the loss of biodiversity, maintain ecological processes, avoid land degradation and conserve vegetation.
- Is not subject to any notice requiring compliance on the development site or vegetation management requirements for particular regulated areas that the proposed clearing may be contrary to.
- Avoids impacts on vegetation and minimises and mitigates impacts on vegetation where avoidance is not possible.
- Does not result in a significant residual impact on a matter of state environmental significance.

# Development Assessment Rules—Representations about a referral agency response

The following provisions are those set out in sections 28 and 30 of the Development Assessment Rules<sup>1</sup> regarding **representations about a referral agency response**

## Part 6: Changes to the application and referral agency responses

---

### 28 Concurrence agency changes its response or gives a late response

- 28.1. Despite part 2, a concurrence agency may, after its referral agency assessment period and any further period agreed ends, change its referral agency response or give a late referral agency response before the application is decided, subject to section 28.2 and 28.3.
- 28.2. A concurrence agency may change its referral agency response at any time before the application is decided if—
- (a) the change is in response to a change which the assessment manager is satisfied is a change under section 26.1; or
  - (b) the Minister has given the concurrence agency a direction under section 99 of the Act; or
  - (c) the applicant has given written agreement to the change to the referral agency response.<sup>2</sup>
- 28.3. A concurrence agency may give a late referral agency response before the application is decided, if the applicant has given written agreement to the late referral agency response.
- 28.4. If a concurrence agency proposes to change its referral agency response under section 28.2(a), the concurrence agency must—
- (a) give notice of its intention to change its referral agency response to the assessment manager and a copy to the applicant within 5 days of receiving notice of the change under section 25.1; and
  - (b) the concurrence agency has 10 days from the day of giving notice under paragraph (a), or a further period agreed between the applicant and the concurrence agency, to give an amended referral agency response to the assessment manager and a copy to the applicant.

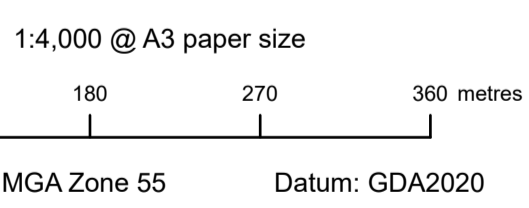
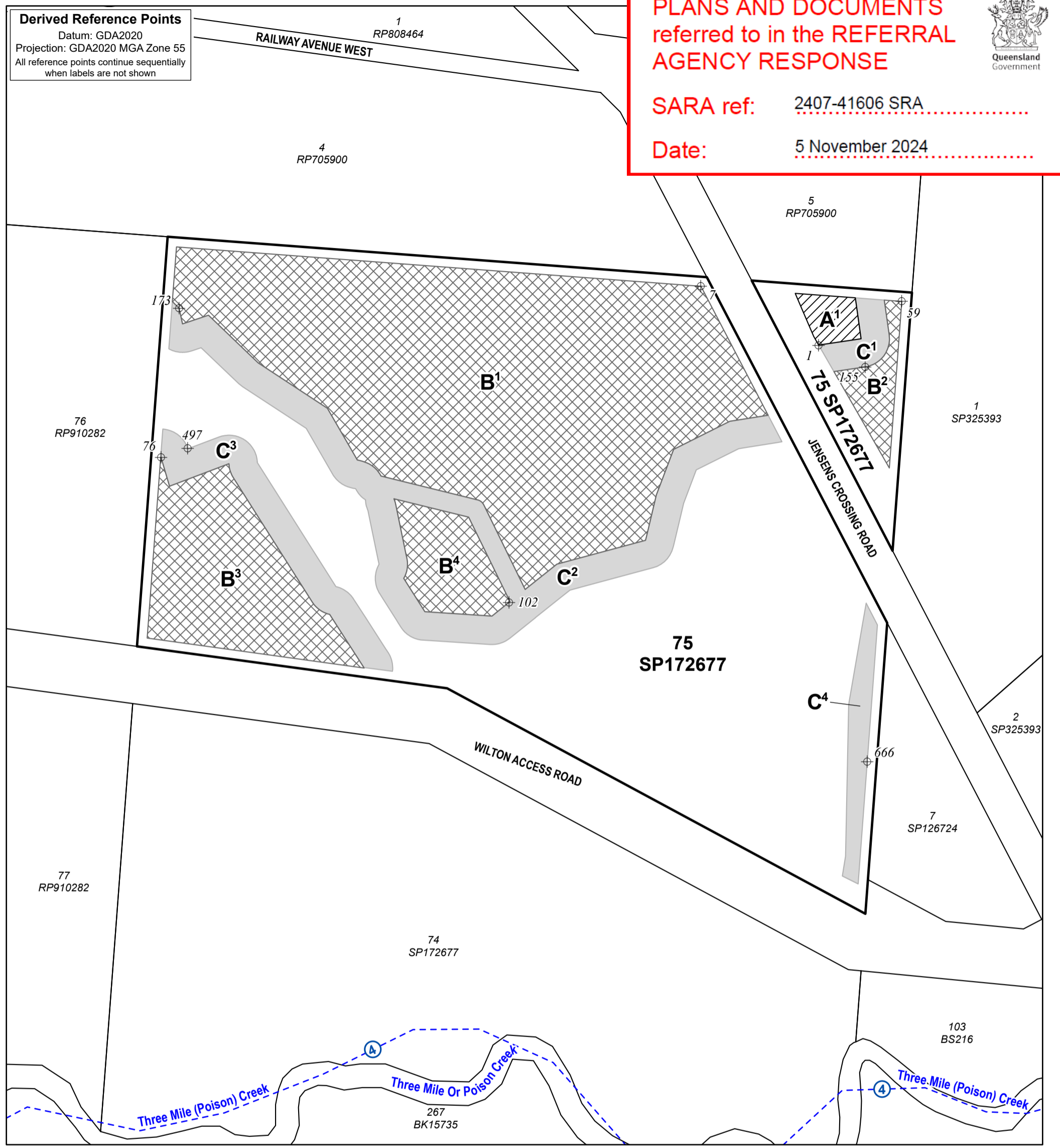
